

**RELEASE OF LIABILITY**  
**PLEASE READ CAREFULLY BEFORE SIGNING**

In consideration of being allowed to participate in any way in *Grandpa Jeff's Trail Rides* programs, related events and activities, I, \_\_\_\_\_ the undersigned acknowledge, appreciate and agree that:

- 1) The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular skills, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
- 2) I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, of *Grandpa Jeff's Trail Rides or Others*, assume full responsibility for my participation and the participation of any minor child accompanying me, and,
- 3) I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual risk or hazard during my presence on the property and especially during my participation in an activity, I will remove myself and any minor child with me and bring such to the attention of *Grandpa Jeff's Trail Rides* personnel immediately; and
- 4) I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEARBY RELEASE INDEMNIFY, AND HOLD HARMLESS THE PROPERTY MANAGEMENT, LLC, ITS OFFICERS, AGENTS AND EMPLOYEES, OTHER PARTICIPANTS, SPONSERING AGENCIES, ADVERTISERS, OWNERS AND LESSORS OF PREMISES USED FOR THE ACTIVITY ("RELEASES") WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHEATHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law; and,
- 5) I grant *Grandpa Jeff's Trail Rides* permission to use my likeness, photographic image, and/or video taped participation, in the event it may be selected for the purpose of promoting this facility.
